

GLOUCESTERSHIRE COUNTY COUNCIL
(A4136, B4228 AND B4028) (VARIOUS SPEED LIMITS IN THE FOREST OF DEAN)
ORDER 2017

The Gloucestershire County Council ("the Council") in exercise of its powers under Sections 1, 2, 4 and 84 of the Road Traffic Regulation Act 1984 ("the Act") and Parts II and IV of Schedule 9 of the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of that Schedule hereby make the following Order:-

1. (i) This Order shall come into operation on the 27th December 2017 and may be cited as the "Gloucestershire County Council (A4136, B4228 and B4028) (Various Speed Limits in the Forest of Dean) Order 2017"
- (ii) This Order affects roads in Various Parishes within the Forest of Dean District in the County of Gloucestershire
2. In this Order –

"Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on the roads as defined in Section 185 of the Road Traffic Act 1988.
3. No person shall cause or permit any Motor Vehicle to proceed along those lengths of roads described in Schedule 1 to this Order at a speed exceeding 50mph.
4. No person shall cause or permit any Motor Vehicle to proceed along those lengths of roads described in Schedule 2 to this Order at a speed exceeding 40mph.
5. No person shall cause or permit any Motor Vehicle to proceed along those lengths of roads described in Schedule 3 to this Order at a speed exceeding 30mph.
6. The Orders described in Schedule 4 to this Order is hereby revoked in relation to the roads described in Schedules 1, 2 and 3 to this Order.

Schedule 1 – 50mph speed limit

A4136 between Huntley and Little London	From its junction with the A40 at Huntley to a point 275 metres east of its junction with the centreline of The Slad (40161)
A4136 known as Barton Hill	From a point 860 metres east of its junction with Dean Meadows (46130) to a point 73 metres east of the centre point of its eastern junction with The Latchen (3/34)
B4228 between Milkwall and Trow Green	From a point 120 metres south of its northern junction with the centreline of Lambsquay Road (3/19) to a point 50 metres south of its junction with the centreline of the B4231 at Trow Green.

Schedule 2 – 40mph speed limit

A4136 Little London	From a point 275 metres east of its junction with the centreline of The Slad (40161) to a point 255 metres west of its eastern junction with Old Hill (50079)
A4136 known in part as New Road and in part as Pump Hill, Mitcheldean	From a point 128 metres south of the centre line of its junction with Baynham Road (40133) to a point 14 metres south west of its junction with The Rocks (45084)

A4136 known as Gloucester Road, Mitcheldean	From a point 275 metres north east of the centre point of its junction with Dean Meadows (46130) for a distance of 585 metres in a south easterly direction.
B4028 known in part as Mile End Road	From a point 250 metres south west of its junction with the B4432 Woodgate Road to a point 67 metres north east of its junction with the B4226 Bakers Hill.

Schedule 3 – 30mph speed limit

A4136 known in part as Gloucester Road and in part as New Road, Mitcheldean	From a point 128 metres south of the centreline of its junction with Baynham Road (40133) in a north easterly direction to a point 275 metres north east of the centre point of its junction with Dean Meadows (46130)
B4028 Edge End Road, Mile End	From a point 200 metres north east of its junction with Wood Road (3/19) to a point 250 metres south west of its junction with the B4432 Woodgate Road.
